**2011 Treasury of Art Show Guidelines  
Eligibility and Entry Requirements**

Artists are invited to submit up to three (3) entries. All entries must be the artist's original work, completed within the last three years. Oil, Watercolor, Acrylic, Collage, Mixed Media, Pastel, Drawing, Hand-pulled Prints, \*Photography, and Sculpture of size and weight easily handled by one person are acceptable media.

*\*Photography entries must be in the edition of one. Accepted pieces can include: Traditional, Digital, and Innovative. Multiple copies of the same image will not be allowed in the show as hanging and/or bin pieces.*

*\*\* At judge's discretion, Graphic Arts & Painting, 3 Dimensional Artwork, and Photography **MAY** be judged separately.*

**The following are not eligible:**

- Work accepted in previous VAS juried shows.
- Work depicting nudes, weapons, drugs or drug-related items.
- Giclee reproductions.
- Works unsuitably framed. Frames must be secure, and gallery-wrapped canvases must have framing wire securely attached. **SAWTOOTH HANGERS are not acceptable.**

**Criteria for Display:**

- Mats must be acid-free board, clean and well cut.
- Tape used to secure work and backing board also must be acid-free material.
- Glazing must be glass or Plexiglas and free of cracks and scratches.
- Entries must be dry and ready for display.
- Entries with outside dimensions larger than 40"x40" (1600 square inches) will be considered two items. Entries consisting of multiple pieces will be considered multiple entries.
- No piece over 48" in any direction, including frame, can be accommodated.
- Sculptor must provide floor pedestal for display if needed.
- All work must be FOR SALE.**

**Sales**

A 25% commission will be charged on all sales, including bin pieces. VAS will collect sales tax.

**Prizes**

At least \$1,500 in prizes will be awarded. Three cash prizes totaling \$600 will be given, plus additional merchandise and certificates.

**Registration and Fees**

**Pre-registration must be postmarked by Friday, November 11, 2011, and is nonrefundable.** The VAS member fee is \$8.00 per piece; the nonmember fee is \$12.00 per piece. To pre-register, all requested information must be provided on the registration form.

On-site registration on Wednesday, November 16, 2011, is \$10.00 per piece for VAS members; \$15.00 per piece for nonmembers. Checks must be payable to the Vienna Arts Society, Inc. and accompany the registration form.

**Delivery**

All entries must be delivered to the Vienna Community Center gym between 6pm and 8:30pm, on Wednesday, November 16, 2011. Please label entry (on the back of hanging art or appropriate place on standing or sculptural pieces) with the following information prior to arrival;

- Your name
- Entry # (1,2, or 3)
- Title of entry
- Medium
- Price

**Bin Pieces**

All registered artists may bring up to three (3) original, matted, unframed pieces for sale in the bins. Mats must be clean and well-cut. All bin pieces must be neatly and securely shrink-wrapped in professional clear art bags.

**Reproductions and giclees are not acceptable.**

Maximum size 22"x28" (616 sq. in.). All bin pieces must be clearly labeled with the artist's name, title of the work, medium and price. This information must also be listed on a 3"x5" card and turned in at the bin receiving table with the respective bin pieces. Minimum selling price per bin piece is \$35.

*\*Photography- see eligibility under entry agreements.*

**Non-accepted Work**

All participating artists should plan to retrieve at least one non-accepted work between the hours of 6pm and 8pm on Thursday, November 17, 2011. **You will be called only if all your entries are accepted.** For this reason, **please provide a daytime phone number on your registration form.** Work NOT CLAIMED AT THIS TIME will incur a \$10/piece/day handling and storage fee.

**Show Closing-** All unsold works must be retrieved on Sunday, November 20, 2011, **NO SOONER THAN 4:30pm and NO LATER THAN 5:30pm.** Unclaimed art will incur a \$10/piece/day handling and storage fee.

**Entry Procedure**

1. Carefully complete and detach the Registration Form below. **THIS INFORMATION IS NOT SUBJECT TO CHANGE,** and Artists are encouraged to **MAKE AN EXACT COPY OF THIS FORM FOR YOUR RECORDS.**
2. Artists are responsible for labeling each entry on the back, upper left. Your labels must match the information on the registration form below. Please attach your labels prior to delivery.
3. To pre-register, mail your registration form and entry fee check payable to the **Vienna Arts Society, Inc. postmarked no later than Friday, November 11, 2011.**
4. Artists are encouraged to bring a one-page Bio for placement in the Artists' Reference Book on Wednesday.
